This represents an increase from the 2015/2016 mil rate of 1.19 mils.
- 16. Captain Todd Meyers of the Nominating Committee presented the Nominating Committee report. Gary Wilcox, President; Dan Coppinger, Vice President; P. Pabich, Treasurer; John Solury, Clerk. It was moved; seconded and carried that the slate of officers presented by the Nominating Committee be elected.
