12. <u>New Business:</u> A discussion took place concerning Town of Simsbury guidelines for business abatements and it was noted that while the agreements for two businesses state that the abatements would not affect the Fire District taxes there was a clerical error in both cases that resulted in reduced Simsbury Fire District taxes billed and collected. A recent discussion with the tax department determined that an administrative or procedural change will correct the problem going forward. A motion was made and passed that the Simsbury Fire District would not look to bill for those back taxes and letters of explanation would go out to those businesses.
