An additional change was made at the meeting to Article V (officers) section 9, replacing it in its entirety. It now reads as follows: "There shall be a District Tax Collector. The Tax Collector of the Town of Simsbury shall serve as the District Tax Collector. The duties of the Collector shall be to collect all tax moneys due to the Simsbury Fire District and the Collector shall promptly pay this money into the hands of the Treasurer, taking receipt of same. The treasurer shall observe the laws of the State of Connecticut made and provided for the collection of taxes." This change was also reviewed and approved and will be sent to the Annual Meeting for final approval.

IT support utilizing the town's personnel is in its final stages. They now have access to all our systems.

The Final Budget with Abatement was presented. A motion was made to approve and move this Budget to the Annual Meeting for Final Approval.
